Reporting Makes a Difference!

June 30th is the deadline to submit your 2012 annual emissions report. Simply visit www.cleanairpartnerstx.org and click on the "Report" tab at the top. A login box will appear requesting your user name and password. If you have forgotten your user name and password or have questions regarding the reporting process, please contact Deanna at deanna@cleanairforce.org.

As a reminder for those new to the Clean Air Partners Program, each Partner reports their annual efforts once a year via the online reporting tool which calculates each Partner's emission reductions, while archiving the data and tracking the percent of total emissions reduced.



Reporting makes a significant impact for many reasons but most importantly it

provides a measurement on the progress that Clean Air Partners are



making towards cleaner air in Central Texas. Partner efforts result in a better quality of life while helping the region avoid non-compliance with the EPA and the rules and regulations that would follow if guidelines were not met. 

There was a great response from the pilot that took place on February 8th, so now there will be one during the peak of Ozone Season. Mission

Clean Cities' mission is to advance the nation's economic, environmental, and energy security by supporting local decisions to adopt practices that contribute to the reduction of petroleum consumption in the transportation sector.

Program

Clean Cities is a community-based, voluntary program that provides a framework for local businesses and governments to work together as a coalition to build on the community's existing Clean Cities' technologies markets. The Clean Cities framework helps coalitions to focus and coordinate the activities necessary to strengthen the existing markets. It also provides a forum to develop partnerships, investigate opportunities for joint projects, leverage resources, and collaborate on public policy.
