2013 Ozone Advance Program

Ozone Advance is a voluntary program developed by the Environmental ProtectionAgency (EPA) in 2012 to promote local actions to help keep nonattainment areas in compliance with the federal ozone standard. The five-county Central Texas region was accepted into the program by EPA on May 23, 2012. This new plan will replace our region's current 8-Hour O3 Flex Agreement with EPA that will expire on December 31, 2013. Participation in this program provides an opportunity for our region to evaluate, select and implement control measures and programs to help keep our air clean. Look for an opportunity to give your input on what you would like to see in the new Ozone Advance Plan from the CLEAN AIR Force in a few weeks. The CLEAN AIR Force will be working with the public, our Clean Air Partners, and other members of the private sector to find new emission reduction measures as well as re-evaluate those already in place. The information gathered by the CLEAN AIR Force will be presented to our Board of Directors and the Clean Air Coalition in the fall of 2013 to assist in developing a successful Ozone Advance Plan for Central Texas.
