Capital Metro's Rideshare Program

Employees who live in or outside of Austin can take advantage of a more economical way to get to work. Capital Metro's RideShare program provides groups of five or more riders with a month-to-month commuter option. The program includes choice of vehicle, insurance, maintenance and 24-hour roadside assistance. Vehicles range from crossover SUVs to standard vans that seat seven to twelve passengers.

The RideShare program is administered by vRide, a national vanpool service provider, under contract to Capital Metro. Through the program, employees can join already existing rideshare groups or form their own. Groups commuting from outside Capital Metro's service area into Austin are eligible to receive a \$550 monthly subsidy to offset the costs associated with the program, while groups traveling exclusively within the service area are eligible to receive \$600. The individual cost per rider will vary depending on vehicle size and number of passengers. The more passengers per group, the lower the individual cost per rider.

Why ride? By participating in the RideShare program, you are helping to

2013 Reporting Results

Congratulations Partners! In 2013 you reduced 92,856 pounds of ozone forming emissions (NOx and VOCs). That makes a total of nearly 2.6 million pounds in the last five years. Although this total number was down from last year, the emission reduction per employee was up 6.8%.

New CAP Financial Policies and Levels of Acknowledgement

During the CLEAN AIR Force Technical Advisory Committee meetings, there have been discussions on ways to improve the Clean Air Partners Program. One way we are doing this is to revise the Financial Policies. This will help attract some of the smaller companies and organizations wishing to join the program.

The policies have been revised to reflect that an in-kind donation of services or materials can be made in

lieu of the annual obligation by up to 50%, and up to a limit of \$250. Partners may apply for this offset by submitting proposed in-kind services and/or materials to the CLEAN AIR Force Director for consideration and approval.

We have also established new levels of acknowledgement for the Clean Air Partners. There will be Platinum, Gold, Silver, and Bronze recognitions. Platinum will be for those Partners that have reached their 10% reduction and continue to strive for even greater reductions. Gold will be for those Partners continuing to reduce and have reached 6% - 9% of their baseline. Silver will be for those that have reached 3% - 5% reductions, and Bronze will be for new Partners and those that have achieved up to 3% reductions.

TCEQ Self Audit Program

For over a decade, the Texas Commission on Environmental Quality (TCEQ) Self-Audit Program has helped businesses of all sizes maintain compliance. Housed in the TCEQ Enforcement Division, the Self-Audit Program is based on the Texas Environmental, Health, and Safety Audit Privilege Act which provides incentives for persons to conduct voluntary audits at regulated facilities or operations of their compliance with environmental, health, and safety regulations and to implement prompt corrective action.

The Self-Audit Program can provide two primary incentives to businesses:

- Limited evidentiary privilege for certain information gathered in a voluntary self- audit; and
- 2. Immunity from administrative and civil penalties for certain violations voluntarily disclosed as a result of such an audit. Neither the privileae nor the immunity applies if an audit was conducted in bad faith, or if the take person fails to timely, appropriate action to achieve compliance. among other conditions.

Additionally, participation through the Self-Audit Program could help to reduce the compliance history score of the business location being audited.
