

OZONE SEASON STATUS IN CENTRAL TEXAS

As of today, the design value for Central Texas is currently 72 parts per billion (ppb)of ozone. While we are currently in attainment of the 2008 Federal ozone standard of 75ppb, EPA is expected to announce a new, lower ozone standard on July 29, 2011.
